Dear Parent / Carer,

RE: Counselling at the Academy

As you may already know, we have a qualified counsellor who works at Skinners' Academy: Jennifer Farnon, our Academy Counsellor, works therapeutically with pupils who feel they could benefit from this kind of support.

Your son/daughter might choose to attend one-to-one, drop-in or group sessions with Jennifer. The purpose of the sessions is to provide your son/daughter with a safe and confidential space where they can make sense of their feelings, thoughts, and behaviour. This can help improve their wellbeing, self-esteem, friendships and understanding of their self, which could also help with raising their achievement.

The sessions are confidential in nature, and they will not be discussed unless we need to share information to keep your son/daughter or somebody else safe. Jennifer does however have regular supervision about her work where information is shared confidentially. This is to ensure that her work with our pupils consistently follows best practice.

The names of any pupils whose parent/carer makes this request will be provided in confidence to the Head of Student Services and the Academy Counsellors. If you do not notify Mr Jay Kerby of any concerns, then we will assume your support for your child to potentially access one-to-one and drop-in sessions and group work.
